# FINE CUT

This festival is a tribute to Fine Cut founder, Jack Larson. In the late 1990's Jack Larson approached KCET with the idea of creating a student film series that would provide talented students with the much-needed opportunity to have their short films selected for television broadcast. Mr. Larson understood how difficult it was for young filmmakers to get broad exposure for their work because, typically, student work is only seen at special screenings and film festivals. Mr. Larson thought that public television was an excellent platform for providing critical visibility to emerging filmmakers. KCET shared Mr. Larson's enthusiasm and together they created *Fine Cut*, which continues to be a flagship program of KCET today.

### **RULES & REGULATIONS FOR SUBMISSION**

The following is an explanation of the Fine Cut Festival of Films rules and regulations ("Rules and Regulations") governing the submission of a Film (as defined in Section II) to Public Media Group of Southern California (PMGSC) for consideration for the 2022 Fine Cut Festival of Films (hereafter called "Fine Cut"). All information contained in this document shall supersede the contents of the FAQ document located at <a href="http://www.kcet.org/finecutrules">http://www.kcet.org/finecutrules</a>.

By agreeing to the Terms and Conditions found on the Fine Cut profile located at <a href="https://filmfreeway.com/festival/FineCut">https://filmfreeway.com/festival/FineCut</a>, the person submitting the Film (hereafter called the "Applicant") confirms that he or she has obtained consent from any and all owners, creators, writers, producers and/or other authorized representatives of the Film whose consent is required to submit the Film to PMGSC, and has read and understood the submission Rules and Regulations as set forth below:

- I. GENERAL RULES AND REGULATIONS FOR SUBMISSION OF A FILM TO FINE CUT FESTIVAL OF FILMS:

NOTE: The submission categories and program categories that are referenced and identified as capitalized terms in this Section I of these Rules and Regulations, and the eligibility requirements for each, shall be understood as having the definitions and descriptions assigned to them in Sections II and III of these Rules and Regulations below.

- 1) The total running time of Any Film submitted into Fine Cut for consideration must not to exceed 25 minutes (00:25:00) inclusive of any Film credits.
- 2) The trailer for each Film ("Trailer") must be in a digital file and must **not** exceed a total running time of a thirty seconds (00:00:30).
- 3) Films and Trailers must be eligible for television broadcast locally in the Los Angeles region and nationally on Dish Network and DirectTV.
- 4) Each filmmaker of a Film and Trailer must grant to PMGSC a license to use and perform the Film in connection with the Fine Cut Festival of Film, in any and all media formats and through any and all media distribution now known or hereinafter devised; including but, not limited to broadcast, festivals, and all forms of "Over The Top" (i.e.,

distribution via the internet) services.

- 5) Films completed prior to January 1, 2020, are not eligible for consideration for Fine Cut.
- 6) Films that have been submitted for Fine Cut consideration in previous years are not eligible for submission for 2022 Fine Cut consideration.
- 7) It is the sole responsibility of the Applicant to secure authorization and permission from the copyright owner(s) of any and all copyrighted and/or trademarked content or materials included within the submitted Film. PMGSC expressly disavows any responsibility for, and will not be held responsible for, any unauthorized inclusion of any copyrighted and/or content or materials within or relating to the submitted Film and Trailer, including any content or materials that are or may become the basis for any Third-Party Claim(s) (as defined in Section I Paragraph 7 hereinbelow) for copyright and/or trademark infringement, trademark dilution, or unfair competition. PMGSC in its sole determination, reserves the right to disqualify any Film with any unauthorized inclusion of copyrighted content or materials. In the event that any claim, dispute, action or proceeding shall be brought or asserted by any person or entity that alleges that the Film and/or Trailer makes unauthorized or unlawful use of any copyrighted content or material, Applicant shall fully indemnify and defend PMGSC, Fine Cut, and each of their representatives and affiliates from any liability in connection therewith and from any fees and expenses, including but not limited to reasonable attorneys' fees, that any of them may incur in connection therewith.
- 8) It is the sole responsibility of the Applicant to clear all content of the Film and Trailer from any and all actual or potential legal claims and issues, including, without limitation, claims based upon theories of libel, defamation, invasion of privacy, violation of rights of publicity, theft of trade secrets, breach of confidence, breach of confidential relationship, and breach of express or implied contract ("Third-Party Claim(s)"). PMGSC expressly disavows any responsibility for, and will not be held responsible for, any unauthorized inclusion of any content or materials within or relating to the submitted Film and/or Trailer that are or may be the basis for any Third-Party Claim based upon any of the foregoing legal theories or others. PMGSC in its sole determination reserves the right to disqualify any Film submission that is or may become the subject of any Third-Party Claim. In the event that any Third-Party Claim is asserted by any person or entity, Applicant shall fully indemnify and defend PMGSC, Fine Cut, and each of their representatives and affiliates from any liability in connection therewith and from any and all fees and expenses, including but not limited to reasonable attorneys' fees, that each of any of them may incur in connection therewith.
- 9) Applicants submitting Films and Trailers that contain significant non-English spoken dialogue must provide on-screen English subtitles and <u>not captions only</u> provided through a streaming platform such as Vimeo. PMGSC in its sole determination reserves the right to disqualify any Film that contains significant non-English spoken dialogue that does not include accompanying on-screen English subtitles.
- 10) There is only one (1) method of entry into Fine Cut. All Films must be submitted to PMGSC via the Secure Online Screener function of Film Freeway, which is located at <a href="https://filmfreeway.com/festival/FineCut">https://filmfreeway.com/festival/FineCut</a> ("Website"). Entry must be made by Applicant only in the manner as set forth herein. All other methods of entry are considered void. PMGSC in its sole determination reserves the right to disqualify any Film entry that is not submitted using the Website.
- 11) In the event that the Applicant remits an updated version of the Film to PMGSC after having submitted a previous version of the Film to PMGSC during the same calendar year, PMGSC is under no obligation to view any or all of the updated version.
- 12) In order for any Film to be successfully considered for entry into Fine Cut, the Applicant must visit the Website (i.e., <a href="https://filmfreeway.com/festival/FineCut">https://filmfreeway.com/festival/FineCut</a>) and follow the links and instructions to complete the required Fine Cut profile. For the purpose of clarity, an eligible Film entry submitted into Fine Cut <a href="mailto:must">must</a> include a completed Fine Cut profile, Film and Trailer. Any entry that does not include a Film, Trailer and Fine Cut profile will not be



considered as entry into Fine Cut. PMGSC in its sole determination reserves the right to disqualify any entry that does not include a completed Fine Cut profile, Film and Trailer.

- 13) Upon completion of the Fine Cut selection process, PMGSC will attempt to contact the Applicant using the contact information provided on the Fine Cut profile to notify the Applicant of the Film's acceptance status. PMGSC disavows any responsibility for, and will not be held responsible for, any failure to contact the Applicant using the contact information provided on the Fine Cut profile. It is the sole responsibility of the Applicant to ensure that the contact information provided on the Fine Cut profile is correct throughout the entirety of the submission period (April 1, 2022 June 3, 2022). Applicants can update their contact information through the Website
- 14) All information and tangible materials submitted to PMGSC will not be returned. No correspondence or any other form of communication will be acknowledged or entered into.

#### II. FINE CUT PROGRAM CATEGORIES & ELIGIBILITY REQUIREMENTS:

Please be advised that the information listed below is subject to change at any time, as our Fine Cut program categories vary from year to year. Films accepted by PMGSC into Fine Cut will be selected for an award (described below), and such determination will be at the sole and absolute discretion of PMGSC.

All Films must meet the submission requirements and abide by all Rules and Regulations and be suitable for publication, which shall be determined by PMGSC in its sole discretion. Film submissions that violate or do not meet the requirements will be disqualified and/or disqualified.

The submission period for Film Cut begins April 1, 2022 and ends June 3, 2022. All Film submissions and Trailers must be received prior to the expiration of the submission period (i.e., June 3, 2022). PMGSC's database clock shall be the official time keeping devise for all entries submitted into Film Cut.

The filmmaker of the submitted Film must be enrolled or have been enrolled in a Southern California College or University as of January 2020 to present.

Applicants must be eighteen (18) years of age or older as of the date of their Film submission into Fine Cut.

NOTE: Films created by a student group that is enrolled in a Southern California College or University class may NOT be submitted by a teacher on behalf of the student group. For the purpose of clarity, Teachers are not eligible to submit a Film for entry into Fine Cut ("Teacher Restriction"). PMGSC in its sole determination reserves the right to disqualify any Film entry that violates the Teacher Restriction.

There is a limit of one (1) Film submission per Applicant.

ALL FILMS SUBMITTED INTO FINE CUT FOR CONSIDERATION MUST MEET ALL ELIGIBILITY REQUIREMENTS AND ABIDE BY ALL FINE CUT RULES AND REGULATIONS

The following is a description of each program category, along with eligibility requirements for each:

#### **FILM CATEGORIES**

There are three (3) film categories for Fine Cut; animation, documentary, and scripted (each a "Category" collectively, "Categories").

All Films selected as a Category finalist into Fine Cuts will be included as part of one (1) of six (6) one-hour broadcast episodes. All Films selected as a Category finalist in Fine Cut will be eligible for awards in the Competition. There

are no premiere or prior screening restrictions for short films. All Films selected as a Category finalist will be part of the broadcast pending they comply with all PMGSC's FCC guidelines.

The winning Film in each Category (i.e., **Animation, Documentary** and **Scripted**) will receive a prize package to be determined.

### JACK LARSON SOUTHERN CALIFORNIA STUDENT FILMMAKER AWARD

The prizewinner of the **Jack Larson Southern California Student Filmmaker** Award will be determined from the Films selected as finalist in each Category. Prize TBD.
