



LINK TV VIEWER SURVEY 2021 SWEEPSTAKES OFFICIAL RULES

NO DONATION OR PURCHASE NECESSARY TO WIN. A DONATION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING, VOID WHERE PROHIBITED

1. ELIGIBILITY: The Sweepstakes is open only to legal residents of California who are 18 years of age or older at the time of entry. Employees of Public Media Group of Southern California d/b/a LinkTV "LinkTV" or "Sponsor") and of companies donating any prizes ("Prize Provider(s)"), as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee, or donating companies are not eligible. Participation constitutes entrant's full and unconditional agreement to these rules and Sponsor's decisions are final.

4. WINNER SELECTION: On or about **September 16, 2020**, one (1) winner will be selected by random drawing under the supervision of Sponsor from all eligible entries received.

5. PRIZE: One (1) LinkTV branded water bottle (estimated retail value is Ten dollars (\$10.00))

Prizes are non-transferable. No substitutions or cash redemptions. In the case of unavailability of a Prize, Sponsor reserves the right to substitute a prize of equal or greater value.

6. WINNER NOTIFICATION. Winner will be notified by email within five (5) days following the drawing. Sponsor shall have no liability for winner's failure to receive notices due to spam, junk e-mail or other security settings or for winner's provision of incorrect or otherwise non-functioning contact information. If winner cannot be contacted, is ineligible, fails to claim the prize within 2 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate winner selected.

Each winner shall be solely responsible for any and all applicable federal, state and local taxes (including income and withholding taxes) relating to his or her acceptance and/or use of the Prize. person to deliberately undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil law and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address.

LIMITATIONS OF LIABILITY: (a) Sponsor is not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind; (3) unauthorized human intervention in any part of the entry process of the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use of any prize.
